Agreement between User and www.system2thinking.org

Welcome to www.system2thinking.org. The www.system2thinking.org website (the "Site") is comprised of various web pages operated by The Rebel Unicorn DBA System 2 Thinking ("S2T"). www.system2thinking.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
